The Chairperson Mr. John K. Tirop (Boda Boda) thanked the Municipal officials for inviting them to the meeting. He mentioned that there are 17 registered stages/groups in Kapsabet town.

- ❖ There seventeen (17) Boda Boda stages in Kapsabet Municipality
- ❖ Boda boda operators are the key stakeholders in our Municipality
- ❖ Boda boda business has no order and rules unlike Matatu SACCOs.

- ❖ We encourage and it is our prayer for Boda boda to do business in a conducive environment.
- ❖ Seventeen (17) Boda boda stages are registered in our office, and all the boda boda riders should handle their customers I humane. Should have good public relation with people.
- ❖ Other Boda boda have stages at banks, government offices and petrol stations and other areas of security concerns

#### **MIN2/06/02/2024 MUNICIPAL MANAGER**

- ❖ All boda boda operators should maintain road safety and adhere to rules regulations.
- ❖ Signages will be placed in all streets at Kapsabet town.
- ❖ Midnight squad should be removed from boda boda stages
- ❖ Namgoi boda boda stages and Matatu should be re-arranged
- ❖ Negative behavior should be banned e.g. aggressive driving, harassment, or illegal activities associated with some boda boda operators.
- ❖ Work together to develop solutions that address safety concerns, improve regulations and promote responsible operations within Municipality.
- ❖ All the boda boda operators should acquire County sticker in order to operate smoothly without disruption.
- ❖ All boa boda members to produce logbook before registration

#### **MIN3/06/02/2024 ENFORCEMENT OFFICER**

- ❖ There is order in some stages, we encourage all the stages to be well organized and arrangement in the same should followed.
- ❖ Alcohol should be discourage and drunkards should not carry customers.
- ❖ Some members operates without safety gears e.g reflectors, helmets and other equipment.
- ❖ There are a lot of obstructions by boda boda riders in town causing traffic disorder/congestion
- ❖ Enforcement officers should be given time to do/enforce their duties without disturbance.

#### **MIN4/06/02/2024 COUNTY HEAD OF REVENUE**

- License and permits: ensure that you have all the necessary license and permits and adhere to local regulations
- Always wear and provide passengers with helmets that meet safety standards
- Obey traffic laws and regulation to avoid fines and maintain a positive image
- Carry proper insurance to protect yourself and passengers in case of accidents
- It is appropriate for members to be in co-operative to enable members to trade with Government.
- Participate in community events and initiatives to build trust and goodwill
- Register Saccos to provide smooth cooperation
